Description

Invitation to Bid for Procurement of Motor Vehicle (Passenger Van)

- The Philippine Science High School- Bicol Region Campus through the General Appropriations Act (GAA) 2018 intends to apply the sum of One Million Six Hundred Fifty Thousand Pesos (Php 1,650,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for procurement of Motor Vehicle (Passenger Van). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Philippine Science High School-Bicol Region Campus now invites bids for Procurement of Motor Vehicle (Passenger Van). Delivery of the Goods is required for a period of sixty (60) calendar days from receipt of Notice to Proceed/Purchase Order. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non- discretionary pass/ fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Philippine Science High School-Bicol Region Campus and inspect the Bidding Documents at the address given below from 7:30 AM to 4:30 PM.

5. A complete set of Bidding Documents may be purchased by interested Bidders on July 26, 2018 to August 16, 2018 from the address below and upon payment of a the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity (www.brc.pshs.edu.ph), provided that bidders shall pay applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Philippine Science High School-Bicol Region Campus will hold a Pre-Bid Conference on August 3, 2018 at 1:00 in the afternoon at Philippine Science High School - Bicol Region Campus, Seminar Hall, Admin Bldg., Tagongtong, Goa, Camarines Sur, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before August 16, 2018 at 1:00 in the afternoon. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on August 16, 2018 at 1:05 in the afternoon at Philippine Science High School – Bicol Region Campus, Seminar Hall, Admin Bldg., Tagongtong, Goa, Camarines Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Philippine Science High School-Bicol Region Campus reserves the right to accept or reject any bid and all bids, declare a failure of bidding, or not to award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
