



## ***Invitation to Bid for Upgrading of Network Infrastructure and Communication System***


1. The **Philippine Science High School- Bicol Region Campus** through the **General Appropriations Act (GAA) 2017** intends to apply the sum of **six million eight hundred thousand (P 6,800,000.00) pesos** being the Approved Budget for the Contract (ABC) to payments under the contract for Upgrading of Network Infrastructure and Communication System. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Procuring Entity now invites bids for Network infrastructure upgrading from Ethernet to fiber optics and upgrading of communication facility. Completion of the Works is required within **120 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found.**
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **Philippine Science High School- Bicol Region Campus** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **March 10, 2017** from the address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **ten thousand ( P 10,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Procuring Entity* will hold a Pre-Bid Conference<sup>1</sup> on March 16, 2017, at 10:00 o'clock in the morning at the **BAC Room, Academic Building I, PSHS-BRC, Tagongtong, Goa, Camarines Sur**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **March 29, 2017, at 10:00 o'clock in the morning**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**  
  
Bid opening shall be on **March 29, 2017, at 10:05 in the morning** at the **BAC Room, Academic Building I, PSHS-BRC, Tagongtong, Goa, Camarines Sur**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The bidders must be involved in System Integration and must have at 2 years experience in undertaking similar project.
9. The **Procuring Entity** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
