



**Invitation to Bid for Supply, Delivery and Installation of ICT Equipment for Implementation of K-12 Program under the Medium-Term Information and Communication Technology Initiation (MITHI)**

1. The Philippine Science High School-Bicol Region Campus through the MITHI Fund intends to apply the sum of one million six hundred thirty three thousand (P1,633,000.00) pesos being the Approved Budget for the Contracts (ABCs) to payments under the contract for Supply, Delivery and Installation of ICT Equipment for Implementation of K-12 Program under the Medium-Term Information and Communication Technology Initiation (MITHI) for 2 lots. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Procuring Entity now invites bids for supply, delivery and installation of ICT equipment. Delivery of the Goods is required sixty (60) calendar days. Bidders should have completed, within **two years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders. **Bidders may participate for any one or both Lots (Lot 1 and Lot 2).**

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *the Procuring Entity* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on Dec. 4, 2017 from the address below if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **two thousand (P2,000.00) pesos for lot 1 and five hundred (P500) pesos for Lot 2.**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Procuring Entity will hold a Pre-Bid Conference<sup>1</sup> on **December 11, 2017** at 10:00 AM at Philippine Science High School-Bicol Region Campus, Seminar, Hall, Admin Building, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **December 26, 2017 at 10:00 AM** at PSHS-BRC, Seminar Hall, Admin Bldg. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on **December 26, 2017 at 10:05 AM** at PSHS-BRC, Seminar Hall, Admin Bldg. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
