- 6. The Citizen's Charter was published in 2009 and underwent review and revision in October 2012 as required under Section 4, Rule IV of the IRR: The office or agency shall review the Citizen's Charter whenever necessary, but not less than once every two years.
- 7. The Citizen's Charter already shows the improvements that resulted from the process review of frontline service delivery, specifically:
 - Revisited and clarified the guidelines regarding the eligible students to take the NCE;

- b. Immediate evaluation and processing of application forms brought by walk-in Test permits are immediately issued to the applicants after applicants. evaluation and processing;
- c. Convenient on line downloading of application forms.
